### Instructions for Completing the Form

- Trainer Information** We have outlined the details as currently held in the GRI database. Should there be any discrepancy, we would be obliged if you could note it on this form. We also request that you complete the telephone number, email address, significant date and personal password sections, the latter two for security questions in relation to your account. You must have these available if you telephone us to inquire about your account.  
**You must inform Greyhound Racing Ireland of any changes to your Trainer details.**
- Account Information** We require five items of information to be completed here. Please confirm with your bank their sort code and complete in full the bank name, address, and account name. Each sort code is 6-digits and each account number is 8-digits. Payments will only be made into mainline bank accounts; this **does not include** credit unions or non-mutualised building societies.
- Remittance Advice** This is a detailed document which will be sent to you detailing all prizemoney earned by you.  
**N.B. Your remittance advice can only be issued by email. Ensure your correct email address is provided.**
- Passwords** The passwords are necessary for security purposes for any communications with GRI in relation to your account, particularly by telephone. The application form requires that you provide two separate passwords of your choice, one a Significant Date Password (an 8 digit number in the dd/mm/yyyy format) and also a Personal Password of up to 26 letters and/or numbers. We recommend passwords that you can easily recall. You should consider keeping a copy of your application form in a safe place. **If you cannot provide the passwords when contacting us to discuss your account, for security purposes, you will be required to submit a newly completed application form.**
- Signature** The form must be signed by you, the trainer.
