### Instructions for Completing the Form

**ICC Owner ID No.** ICC Owner ID number must be entered by you. This number is can be located on your greyhound's 'Certificate of Registration'. It will be located on the right hand side, midway down the page, opposite your name. Alternatively it can be obtained from the Irish Coursing Club on (052) 6188504 /6188505 /6188506 /6188507

**Owner Information** We have outlined the details as currently held in the IGB database. Should there be any discrepancy, we would be obliged if you could notify the Irish Coursing Club as the information within our database is received from the ICC. We also request that you complete the telephone & fax numbers, email address, significant date and personal password sections, the latter two for security questions in relation to your account. You must have these available if you telephone us to inquire about your account.

**Account Information** We require five items of information to be completed here. The name on the bank account will generally be your name i.e. John Smith. Please confirm with your credit union their BIC & IBAN number and complete in full the **BIC number (8 digits), IBAN number (22 digits)**, the bank name and address. Payments will be made into any working bank account or building society. Postbank and small number of Credit Unions can also be used (for details contact your Post Office, Credit Union or Direct Credit Section).  
***N. B. Prize-money can only be paid into an account held in the name of the owner/breeder. We are prohibited from making payments into accounts other than the owner's account.***

**Syndicates/Joint Owners** In relation to syndicates/joint owners, every member of the syndicate or joint owners must sign their name in the space provided indicating that they nominate the account holder to receive all prize-money on behalf of the syndicate/joint owners. In the case of a syndicate, a copy of the Syndicate Registration form from the Irish Coursing Club must be included with the form.

**Remittance Advice** This is a detailed document which will be sent to you detailing all prize-money earned by you. Please indicate, by ticking the relevant box, whether you wish to receive your remittance advice by post or email. Ensure your correct email address is provided.

**Signature** The form must be signed by you, the owner and account holder.

**Passwords** The passwords are necessary for security purposes for any communications with IGB in relation to your account, particularly by telephone. The application form requires that you provide two separate passwords of your choice, one a Significant Date Password (an 8 digit number in the dd/mm/yyyy format) and also a Personal Password of up to 26 letters and/or numbers. We recommend passwords that you can easily recall. You should consider keeping a copy of your application form in a safe place. **If you cannot provide the passwords when contacting us to discuss your account, for security purposes, you will be required to submit a newly completed application form.**
