

RCÉ KENNEL IMPROVEMENT SCHEME

INTRODUCTION

The Board of RCE recognise that, heretofore, the main method of distribution of funding through the greyhound racing industry, has been prizemoney. The Kennel Improvement Scheme was devised to ensure money is available to the greyhound Industry to assist in the modernisation and ongoing improvement of the surroundings within which greyhounds are kept, with a view to improving the welfare of these animals

BACKGROUND

The Board of RCE has taken the decision to assist the greyhound industry in accepting applications for funding to subsidise construction works which are necessary to improve the welfare of the greyhounds residing there. RCE proposes that on receipt of a successful application that it will assist the applicant with a contribute up to 75% of the cost to a maximum of €2,500. The Board has ringfenced €100,000 per annum for this project and once the initial fund has been allocated, applications will be suspended until the following year.

OBJECTIVE

The objective of the Scheme is to assist in the development and improvement of existing kennelling facilities within which greyhounds are kept in the Republic of Ireland. However, this Scheme is not designed to facilitate the expansion of kennels.

APPLICATION

Eligible Works

Any works that will improve the welfare of greyhounds owned and kept at a greyhound kennels. The works must take place on the property of the greyhound owner/trainer. If the property is not owned outright, a signed long lease (minimum 5 years) agreement must be in place. Works must be inspected and approved prior to commencement and must be deemed as necessary to tangibly improve the welfare and quality of life at greyhounds kept at that kennels/property. Registered trainers can apply for the scheme. The works must take place where the applicant keeps dogs at the premises. Premises must be in the Republic of Ireland

Example: An owner of a dog being kept at a professional kennels may not apply for improvement works at that kennels as they do not have a tangible interest in those facilities and may remove the animals to better facilities should they chose to. However, if owner is a professional trainer, they may apply.

- If Kennels are leased/rented, then a copy of the lease/rental agreement must be submitted.
- Kennel Site must be visited and deemed necessary to the improvement of animal welfare on site by a GRI Welfare Officer, this may include works identified upon a satisfactory welfare

inspection as necessary. In this case, the visit where the works were discussed and recorded on the inspection sheet may count as the first visit.

- An Owner/Trainer can only benefit from this scheme once.
- Successful Owners/Trainers may be asked to furnish three quotes for the works approved prior to payment.
- Premises that avail of this scheme are then precluded from availing of this scheme for at least 5 years.
- Payment will only occur after a second satisfactory site visit by the same welfare Officer and a paid invoice has been supplied as proof of payment.
- An Independent Engineers certificate that all construction methods employed, and materials are up to the required specifications and regulations, may be requested.

Ineligible Works

- Works that have begun before the Official Launch of the programme
- Works that have begun before a visit by RCE Welfare Officers have taken place
- Works that are not necessary to tangibly improve the welfare of the animals kept at the property

Examples of Ineligible Works

Example	Reason for exclusion
Installation of a Sand gallop	Does not improve greyhound welfare
Installation of a bigger/better walking device	Does not improve greyhound welfare
Installation of Interior Spec Doors to	Materials used are not fit for the purpose
Outside Openings	they are being used and not to building regulations
Installation of Second-hand Doors to	Materials may not be to Building
Kennels	regulations Required

TERMS & CONDITIONS

The Conditions of suitability to this scheme will be reviewed on an ongoing basis. All works must fall within the conditions of the Scheme. RCÉ reserve the right to refuse applications. All dogs on the property must be RCETS compliant at the time of application and throughout the process until payment. Incomplete applications will not be accepted for consideration, the entire application form must be completed. Works must only be completed by a VAT registered construction operator, independent of the applicant. Preference will be given to kennels that have rehomed/retired greyhounds.

Applicant Kennels must remain compliant under the RCE Code of Practice for the care and welfare of greyhounds along with all greyhound welfare, animal welfare and veterinary medicines legislation throughout the process, up to the point of payment. Failure to comply, at any point, may result in suspension of the grant pending an investigation which may result in loss of the grant and rejection from the scheme.
