3. Where an owner, trainer or agent of the greyhound does not comply with testing procedures including the re kennelling of the greyhound post trial, this greyhound will be immediately withdrawn from the auction
4. In the event of a greyhound being sold at a Greyhound Sales the **Registered Owner is required to update the RCETS system following the Sales**. The name of the purchaser of the greyhound will be provided to the Registered Owner by Management of the Sales venues.

2. Identity Card of greyhound to be held by the Racing Manager for up to 14 days after the sale if:
 - a. Failing to show on the day,
